On 13 March 2015, the Company announced that Mr Zhu had acquired, from Black and White Investments Limited, a total of 2,835,000 ordinary shares of 1p each in the issued share capital of the Company representing approximately 8.74 per cent. of the issued share capital of the Company.

Mr Zhu is currently the Executive Chairman of GNet Group plc, an ecommerce business based in the People's Republic of China, which provides O2O ("Online to Offline and Offline to Online") services. Mr Zhu is also Chairman of Sun Shine Holdings Group Inc., a position which he has held since 2000. Sun Shine Holdings Group Inc. has a diversified business in the wholesale and retail trade, it also provides funds for investment projects, real estate development consulting services, business management consulting services and computer technology services. Since graduating from Beijing Agricultural Industrial University with a bachelor's degree in 1985, Mr Zhu has held a number of senior positions with different Chinese corporations and also studied at Guangdong Academy of Social Science between 1988 and 1990.

The Board's understanding from Mr Zhu is that it is his intention to build a significant investment in the Company either through market purchases or a new subscription, if available. The Board is also in preliminary discussions with Mr Zhu as to how his contacts within the media and entertainment industry and providers of finance in Asia could assist Gate Ventures to expedite its Investing Policy as set out in the Company's Admission Document dated 10 March 2015.

Subject to completion of due diligence and compliance with the AIM Rules, it is the intention of the Board to invite Mr Zhu to join the Board as Non-Executive Chairman, at which time, Geoff Morrow, the current Executive Chairman will become the Company's

Executive Deputy Chairman. Further announcements will be made to the market as and when appropriate.

Geoff Morrow, Executive Chairman of Gate Ventures, said: "My fellow Directors and I are delighted to welcome Mr Zhu as an investor in Gate Ventures and we look forward to furthering our discussions with Mr Zhu how he might be able to assist the Board in expediting the Company's Investing Policy. We look forward to making further updates in due course."
